To gain Associate Membership approval, the business must be allied to, involved in or associated with the boating industry.
- Probationary Membership***
Probationary Membership is available in each of the above categories to applicants who have not been engaged in the marine industry for more than 12 continuous months but who meet all other Membership criteria. Probationary period is for one year from the applicant's approval
